



Conditions of participation FAIRTIQ

By participating in the FAIRTIQ AG competition, Aarberggasse 29, 3011 Bern, you agree to the following conditions of participation.

Eligibility:

All persons resident in Switzerland, Liechtenstein and Germany who have reached the age of 18 are eligible to participate.

Procedure of the competition:

The competition is open to those who are eligible from 02/09/2022 to 08/09/2022 and meet the following three criteria:

- Complete registration in the FAIRTIQ app, including an email address
- No unsubscription from the FAIRTIQ newsletter
- Completed a journey* with the FAIRTIQ app on at least one day within the specified week in a FAIRTIQ region in Switzerland, Liechtenstein or specified regions in Germany*

Chances of winning:

The chances of winning increase in proportion to the number of days within the specified week on which at least one completed journey was made with the FAIRTIQ app in a FAIRTIQ region in Switzerland, Liechtenstein or specified regions in Germany (max. 7 days).*

*The trip counts, provided that

- A trip with public transport as well as the check-in and check-out in the app were correctly performed at two different stops and the trip could be charged correctly
- The trip is done in one of the following regions: Switzerland, Liechtenstein, KVV, RVL, HAVAG, Flensburg, VVO/DVB, MVB, VAB, VAG/RVF, VBN, VMT, WVV, RNN

Determining the Winners:

The winners will be selected at random from all participants in the following week and notified by e-mail. The winning participants must accept the prize by agreeing to it in the e-mail. In the absence of consent or rejection of the prize within the specified period, the draw will be repeated once. Participation in the contest is free of charge, only the price of the trips made will be charged.

Miscellaneous:

The legal process is excluded. No correspondence will be entered into by FAIRTIQ regarding the competition, except with the winners.

The organizer is entitled to make adjustments at any time and, in particular, to suspend, cancel, prematurely terminate or extend the competition in the event of force majeure, closure/shutdown of websites/applications, manipulation by third parties/participants, technical failure or other reasons.
